# **DISCOUNTS**

Only <u>one</u> of the following discounts may be applied. Two or more tuition discounts cannot be combined. Only applicable to students in Preschool-Grade 8.

- **Sibling Discount:** Offered to families with multiple children attending St. Michael School. The discount is equal to 10% of the tuition cost for each additional child enrolled after the first child.
- Military/First Responders Discount: Offered to families of full-time active military personnel (Air Force, Army, Coast Guard, Marine Corps, and Navy) and families of full-time first responders (police, fire, EMS, ocean safety). The discount is equal to 10% of the tuition cost.

• **Parish Discount:** Offered to families who are actively involved with ministries at St. Michael Church. The Annual Application for Active Parishioner Tuition Discount form, signed by the pastor, is required. The discount is equal to 35% of the tuition cost for <u>new</u> students or 25% of the tuition cost for <u>returning</u> students.

# OTHER DISCOUNTS

- **Early Enrollment Discount:** Families are eligible for the former k-8 tuition rate (\$8,050) if the Comprehensive Fee if paid before April 5th. A further \$250.00 discount will apply if tuition is paid in full by June 30<sup>th</sup>.
- **Referral Incentive Program:** Refer a family member or friend to St. Michael School and when their child(ren) enrolls as a student(s) for the upcoming school year, you will receive a \$250.00 credit per student enrolled towards your family's tuition.
- Automatic Payment Deduction: Families who sign-up for automatic payment deduction through FACTS will qualify for a \$100.00 tuition credit.

## FINANCIAL AID & OTHER INFORMATION

- Financial aid scholarships available through agencies such as the Augustine Educational Foundation, Kamehameha Schools, Preschool Open Doors, and others.
- Tuition Loan Programs are normally available at local banks. Check with your financial institution if they also have similar programs available.
- Families with 529 educational investment accounts may use tax-free withdrawals up to \$10,000 toward tuition costs.
